 - First Home Game is in 2 weeks, donations and volunteers will be needed; sign ups will go out soon, Mr. McGehee states he might have someone that can donate the potatoes for our games, just needs to know how many for each game.
 - Mrs. Amaya requests we get new or heavy duty can openers as the ones we currently have are not good quality and it is hard to get the cans opened, boosters will be getting new can openers.
 - Field Season Props – we will be using both back and front props and looking to use about 9 stars and will be repainting the frames and ordering new vinyl images; Mrs. Johnson states she has contacts with graphic designers that can help with the designs for the props.
 - We need approval to purchase more Falcon I's for the band uniforms, the cost is \$2,229.80 for 160; Nathaniel Ventolieri & Cheryl Whipple motioned to approve, all ayes.
